#### **PREFACE**

#### History of ANSA.

ANSA originated as result of fishing developments following the war, an increasing number of anglers started using modern tackle mainly bait casting rods and reels imported from the U.S., for bass, barramundi and for surfcasting. Developments are reflected clearly in magazines of the period. (Outdoors was first published in 1948, Anglers Digest in 1950).

There was an increasing recognition that the sporting value of many Australian species was not reflected in existing organisations.

From 1960 forward, a number of people had thought of the idea of a new sportfishing organisation. I do not know who was "first" to think of it but I do know that it was discussed for quite a few years by Sydney anglers and people such as myself - a country boy. I can put a finger on one such discussion, held on the roadside just south of Kiama, between myself, Jack Erskine and Ed Pratt. That was January 1964 during my first round Australia trip. I had started my exploration of Australian fishing on July 1 1963. The next couple of years, after repeated visits, I had realised that North Queensland offered the most potential for a fishing future. Others such as George Bransford had decided the same way.

I built my home in Cardwell in 1966, with the bricklaying being done by my friend Ed Pratt, who had moved north to Cairns about the same time. The ANSA concept was understood by a number of Cairns anglers, and I believe its success came because it reflected what was happening to Australian fishing. It could not have succeeded otherwise.

In February 1967 we formed the "Australian National Sportfishing Association" at a meeting in the old hall at Yorkey's Knob, just north of Cairns.

Within a few months a constitution had been drawn up and an account opened in the Cairns branch of the Bank of NSW in the name of the "Australian National Sportfishing Association" It is worth a mention that the late Wal Hardy was patron of that initial organisation.

Dick Lewers recorded that the NSW group "got the message" of the Cairns movement and responded by forming what was then the NSW division of ANSA on Saturday August 12 1967.

Three months later, in November 1967, Jack Erskine and Clyde Kelton with three NSW sport fishermen from Wollongong, John Kettle, Peter Fuller, and Bill Ferguson visited North Queensland in a light plane. Discussions took place with the Cairns group and the accepted name of ANSA was endorsed by both groups. However, it had already become clear that the NSW fraternity would not accept the Cairns constitution. Then, as now, State Divisions (branches) were more representative of regional interests. Accordingly, the Cairns ANSA group met on February 7 1968 and became instead the Cairns Sportfishing Club.

At this time there was no Queensland Division as such, however Dick Lewers and the National Organisation have always recognised that the Cairns Sportfishing Club has the unique distinction of being the first ANSA club.

The first NSW ANSA club was the St.George Sportfishing club, which had its first general meeting on November 13 1968. On December 13 1969 the first official body was formed as the "Australian National Sportfishing Association". The original A.N.S.A. badge design was selected from a competition published in "AUSTRALIAN SPORTFISHING", Summer edition 1969. The winning design was submitted by John Renolds, Liverpool, NSW.

It was agreed to form the first record chart from the then existing Queensland and N.S.W. record charts. ANSA's first official Queensland division was formed on August 5 1970 with only three clubs - Cairns, Maryborough, and Cardwell, with a State total of 150 members.

So far as ANSA goes the story since has been one of steady growth. We now have more than 200 clubs Nation wide. We are represented on every State fishing council, at Federal level, and on IGFA. Looking back we can see that the hassles over constitutions and rules, even point scores, were part of the process of developing sportfishing on a truly representative and wholly Australian basis.

One of the nicest thoughts is that many of those people who contributed to the forming of the association are still with us today.

#### **National Chairman's Report**

The year has been a busy one with many items affecting recreational fishing in Australia. Probably the biggest threat was from the largest fishing trawler ever to be allowed to enter Australian waters. The "MARGIRIS" super trawler was initially allowed into the waters of our southern ocean in 2012.

This resulted in probably the biggest people rebuttal in our recent history. Thankfully this prevented the vessel plundering the ocean for the small pelagic specie that feed many of our larger blue water fishes. With nets as large as the Sydney Harbour Bridge the devastation would have seen the end of what we know as the food chain of larger species.

Several different organizations accepted the challenge as well as ANSA, ARFF and Recfish to stop the government of the day from going ahead with the plan. The "Keep Australia Fishing" website was very aggressive with information and this coupled with other submissions and personal representations with politicians from all sides of the political fence thankfully resulted in the back down of the government plans to license the Margiris to fish in Australian waters. Hopefully the newly elected Australian government will not reopen the door for the Margiris, or any other super trawlers to return to our national waters.

The planned marine reserves have also been a contentious issue with ANSA placing several submissions before the Australian government challenging the proposed lock out of recreational fishers from vast areas of the Australian ocean when other more threatening activities would be permitted. Now that has been a change of government the onus is on the Coalition to now make good its promise to review the entire marine reserve planning process and deliver a better deal for recreational fishers.

A new rulebook was published and sent to all branches in late 2012 for distribution to club members. Production and distribution of the rulebook is quite a large expense for ANSA (around \$5000 plus postage). With the growing popularity of the Internet and availability of modern technology members also have ready access to the latest rulebook on the web site. The next review of rule changes is scheduled for 2016.

Some ANSA affiliation fees have been reduced. Senior fees have been reduced from \$10.00 to \$8.00 and junior members fees have been discarded. All other fees remain the same. These fee reductions have been possible due to better communication systems used by National. The use of the Internet and emails has reduced the need for face-to-face meetings and the savings have been passed on to members.

The Angel Ring project continues to grow under the stewardship of Stan Konstantaras, National Safety Officer. The Angel Ring project initiated by ANSA NSW some 30 years ago has so far saved over 30 confirmed lives. Angel Rings are now being installed in all States where rockfishing is prevalent. FRDC will be contributing \$90000 in grant moneys for the Angel Ring national rollout.

No changes occurred in the National Executive. Ken Johnson and Phil Turner have kept me busy with record updates and Knut Gasmannis has soldiered on with Masters records. Sue Malton has handled the finances without any problems and Joe Garufi continues as membership and ANSAWARE Director.

Bill Sawynok is our Research Director and though we rarely see him he has been extremely active with FRDC and other organizations promoting fish tagging and looking after tag research for those requiring recapture data for research purposes.

John Burgess, Executive Officer, what can I say, without John ANSA would not have the high public profile it has today. John constantly represents ANSA on all manner of issues relative to recreational fishing. John is a board member of the ARFF and Recfish Australia and represents ANSA on a wide range of commonwealth and state committees dealing with issues of critical significance to ANSA and its members.

To the entire executive I give my thanks. Being in the far north of this great country there is little opportunity to mix with the people that make our laws. We are indeed lucky to have such an active national board that can meet with the movers and shakers and put forward our angling aspirations. We all hope for a better future for all recreational anglers and that our freedom to fish anywhere continues for our children.

#### **National Executive Director's Report**

Another challenging and busy year for ANSA at both a National and branch level. Listed below is a snapshot of some of the many issues concerning recreational fishing that ANSA has been actively involved in over the past year.

National Marine Reserve Network. At a national level ANSA has worked closely with all commonwealth government agencies associated with the rollout of the national marine reserve network. Fortunately for NSW recreational fishers the declared marine reserve zones off the NSW coast are a long way off shore and not easily accessible by ordinary recreational vessels. Unfortunately though, recreational fishers in WA and Old did not fare as well as NSW with the Coral Sea "no fish" zones being about twice the size of the state of Victoria. ANSA in conjunction with all other national and state peak recreational fishing bodies has tried in vain to negotiate a better outcome for recreational fishers with the Federal Government. The roll out of the marine reserve network is now at the final stage of completion with the management plan regulations passed through the house of reps but still to go through the senate. Progress of the management plan through the senate has been put on hold because of the pending elections. Also the Coalition has a disallowance motion against the regulation listed with the senate. ANSA and other peak bodies have requested an immediate independent scientific review of the commonwealth marine reserve process and a more fisher friendly interpretation of IUCN11 categorisation which defines recreational fishing as an extractive industry and therefore a non allowable activity. It will be interesting to see what impact the Federal election will have on the marine reserve rollout. A full review of the marine reserve planning process has been promised by the Coalition. ANSA will continue to be engaged in the marine reserve debate regardless of who is in power.

**Supertrawler**. While ANSA and other like minded peak body groups have been successful in stopping the trawler from pillaging our bait fish stocks in southern waters, this threat keeps on resurfacing. Sea fish Tasmania, the company behind the planned use of the Margiris supertrawler to fish for small pelagic species in Australian waters has appealed to the Federal Court against the government's 2 year embargo on use of the supertrawler pending the outcome of a environmental impact assessment of the supertrawler 's operations. The Federal Court has not yet handed down a decision so let's hope that the legal system will keep the supertrawler well away from our small pelagic/bait fishery. Also now that there may be a change of government in Canberra there are concerns that the Coalition may make good its pre election commitment to overturn the 2 year embargo and throw its support behind the supertrawler proposal. Hopefully common sense will prevail here and our small pelagic fishery will remain protected from the ravaging impacts of supertrawler operations. If not then the battle to protect our commonwealth fisheries will be on again.

Caltex Dredging. ANSA has formally asked the Federal Environment Minister to intervene in the proposal by Caltex to dredge and expand its berthing facilities at Kurnell (Botany Bay) and to dispose of some 153000 cubic metres of TBT contaminated sediment by dumping the bulk of it at sea 10km south east of Sydney Heads - TBT is a very toxic substance historically associated with anti fouling. NSW authorities have given a conditional green light to the dredging proposal but the dumping at sea requires Commonwealth approval. ANSA's preference is that the contaminated spoil be treated and disposed off at an appropriate land fill site. Compensatory offsets for loss of recreational fishing access will be sought from Caltex regardless of the outcome.

**Grey Nurse Sharks.** ANSA has had a long and active role in the management of GNS and we did participate in the NSW review of GNS Critical Habitat Zones and the type of fishing activity and tackle allowed in some of these zones. Outcomes of these reviews saw the revocation of GNS critical habitat at Bass Point and modification of the shape of the habitat zone at Magic Point (Maroubra) and Green Island (South West Rocks). Land based line fishing with bait is now allowed adjacent to these modified zones. ANSA is still engaged with the National GNS Recovery Plan and is hopeful this document will be publicly released soon - it has been in draft form since 2009. It is very clear that more research is desperately need to get a clearer picture on the size of the eastern seaboard GNS population. Pleasingly some of the more recent research has shown numbers to be substantially in excess of those low number of around 400 that have been frequently mentioned in the media. The current estimate of GNS numbers on the east coast is now between 1131 and 2142 individual sharks. Anecdotal evidence is that the population number is well in excess of these estimates as the period and location of the latest research was very limited and hampered by bad weather. While we will never know exactly what the GNS population is there is some comfort in the in the knowledge that the latest figures are a vast improvement on those estimated in 2004 and it is arguable that the population has increased or the earlier research estimates were incorrect or a combination of both.

**Boat Trailer Parking.** Most owners of boats over 6m in length would probably be unaware that it is illegal to park a vehicle (including a trailer over 7.5m including whatever is loaded on the trailer) on a public road in a built up area for more than one hour. A number of Sydney coastal and harbour side councils have been pushing for some time have the National Road Rules amended so that they have very broad delegated powers to issue infringement notices and impose penalties for parking of boat trailers of any size on public roads. To date councils have not been given these powers but a Boat Trailer Working group was established by the NSW government last year to consider all options. A report and recommendations have been completed and these have yet to be decided upon by the NSW government. Regrettably though Councils do have the power under section 200 of the Road Rules to impose fines on parked trailers over 7.5m in length. Historically few councils have opted to exercise this delegated power until now. One eastern suburbs council has issued warning notices to all boat/ trailer rig owners over 7.5 m to move their boats off the road or face heavy fines. None of these trailers were parked unsafely and all were registered and in regular use. The concern now is that this precedent may spread to other councils. ANSA has taken this issue up with the NSW Minister for Roads and Ports and has requested ACORF to write to the NSW Fisheries Minister seeking her intercession. ANSA has also via its membership of Recfish and ARFF requested the intervention of all national and state recreational fishing peak bodies and the issue will be raised with the Federal Roads Minister. Rule 200 has application not just in NSW but across all states and territories. Hopefully we can get this sorted out before the cancer spreads.

**Fishing Safety.** ANSA continues to take the lead on fishing safety issues both in NSW and nationally. The Angel Ring project which has save numerous lives in NSW is being rolled out nationally and ANSA has been at the forefront in the debate about the compulsory wearing of life jackets by land based fishers. Safety Officer Stan Konstantaras will go into more detail on these issues in his report.

Murray Darling Basin. ANSA in conjunction with other peak recreational bodies has formally voiced concerns that the issue of recreational fishing was not initially factored into the political debate on the future management of the MDB. This has been rectified but there are still a lot of conflicting issues to be sorted out between the various states and the commonwealth in terms of water allocation and how our water reserves are prioritised but hopefully in the final wash up we will end up with a much healthier river system and a better and more productive vital inland fishery.

**State Marine Parks.** ANSA has also taken an active role in the planning and review of state marine parks as these are the source of most angst and concern for recreational fishers given their close proximity to the coast and spread over much of the state's coastline. For better or worse it is now fashionable for all Australian states to now have their own networks of state marine parks and the locations of these marine parks and the zonings do have a major impact on both land and boat based recreational fishing with access to favoured and safe fishing locations frequently being declared off limits. If your state branch requires assistance and support from ANSA national in dealing with these challenges then let us know.

NSW Marine Parks. ANSA did participate in the independent audit of NSW marine parks and we have had preliminary meetings with the members of the newly formed NSW Marine Estate Management Authority and the Marine Expert Knowledge panel which have been set up to replace the NSW Marine Parks Authority and to manage the entire NSW marine estate which includes all coastal waters, estuaries and beaches. One of the immediate benefits to come from all of these activities was an amnesty to allow recreational line fishing from ocean beaches and headlands in most marine park sanctuary zones. An assessment of the impacts of this amnesty is currently in process. ANSA has high hopes that these new bodies will engage with recreational fishers and that the outcome will be a better coordinated management of our marine estate with proper regard to recreational fishing as an important socio economic activity.

**Cronulla Fisheries.** Despite a strong campaign to stop the closure of Cronulla Fisheries, including ANSA appearing before an Upper House inquiry, the closure went ahead with a resultant loss of over 100 staff not prepared to relocate to regional offices. The loss of so many key research and management staff has had an obvious impact on Fisheries. Those that have stayed on are doing a great job under difficult circumstances. Thankfully the department is now in the process of recruiting new staff and time will hopefully see NSW Fisheries back on top of its brief.

**Botany Bay.** ANSA has been represented on a number of committees associated with the expansion of Port Botany. ANSA has been fortunate to stop a number of proposals to restrict fishing access on waters adjacent to the port .The issue of compensation for loss of much of the bay (which is a recreational fishing haven) as part of the port reclamation has been a sore point for ANSA for many years. We have unsuccessfully pushed the case for compensation with a variety of responsible Ministers over the past decade. Now that Port Botany has been privatised and sold the NSW government has undertaken it will provide funding for the installation of 2 offshore artificial reefs south of Botany Bay as part of a compensation package. A similar off shore artificial reef compensation package has been negotiated for the south coast following privatisation and sale of Port Kembla.

Review of NSW saltwater/ Freshwater Fishing Rules. Both ANSA NSW and ANSA National have participated in the review process and have questioned the lack of science and purpose behind the proposed bag and size limit reviews which essentially involve a halving of bag limits for most bread and butter species. None of these species is under threat from recreational fishing or is overfished. There has been no evaluation of the conservation effectiveness of the rule changes introduced in 2007 or any assessment of the impact the reduced bag limit changes will have on recreational take if adopted and made law. Hopefully good common sense will prevail and any changes, if implemented, will have minimal impact on recreational fishers and will not infringe upon the capacity of recreational fishers to exercise value decisions on how many fish to take and keep.

**Peak Bodies / Committees.** ANSA remains a full member of Recfish Australia and is one of the foundation members of the recently established Australian Recreational

Fishing Foundation (ARFF) which is a new national peak body which will hopefully combine the membership of all national and state recreational fishing peak bodies and industry players including the Australian Fishing Trade Association (AFTA), the Boating Industry Association of Australia (BIAA) and Keep Australia Fishing (KAF). This new body which is based in Canberra will forge the future basis for collective action on all national issues that have a relevance to recreational fishing. ANSA is a full member ARFF and I am the ANSA representative on the ARFF Board. ARFF has been extremely influential in raising the profile and concerns of recreational fishing at a high political level in Canberra and will continue to professionally represent recreational fishers on all issues of national significance. Some of the major issues we have joined forces with ARFF and KAF have included the Commonwealth Marine Reserves rollout, blocking the Margiris supertrawler, review of Commonwealth Fisheries Management, Development of a National Recreational Fishing Charter, opposition to the listing of Smooth Hammerhead sharks as vulnerable and a very successful politicians fishing completion which will hopefully become an annual event. ANSA was also a member of Minister Ludwig's Recreational Fishing Round table which met quarterly as a forum for open discussion between the recreational sector and the Fisheries Minister and senior staff from all commonwealth fishing and environmental agencies on all issues material to recreational fishing. Whether there will be a Roundtable in one forum or another beyond the elections is uncertain. ANSA continues to hold positions on a wide variety of commonwealth and state government consultancy committees. ANSA is also a member of the International Game Fish Association (IGFA) and both Bill Sawynok and myself are Australian representatives on that body.

Membership – Membership Services and Financial. From a membership and financial perspective ANSA is travelling well. Our membership numbers have remained fairly constant and a number of new clubs have joined the ANSA ranks. Cost effective measures have enabled us to reduce the senior membership fee from \$10 to \$8 and to remove entirely the junior membership fee. New ANSA promotional brochures have been produced and are available at no cost to member clubs and or branches. ANSA promotional banners have also been provided to most state branches at no cost and sufficient 2012 rule books have been distributed to the branch network to ensure every member has a personal rule book. Additional rule books are available upon request. New stocks of high quality ANSA brag mats are now available for sale and a new website has been established and there is now an ANSA facebook page (<a href="https://www.facebook.com/ANSA.National">www.facebook.com/ANSA.National</a>) for those who like to be tech savvy.

**Thank you.** ANSA could not undertake all of its activities if it were not for the very small team of dedicated volunteers at a branch and national level who generously give up their time to get involved in these issues. I would especially mention Ron Poole our Chairman and Webmaster. Ron has been the ANSA Webmaster for as long as I can remember and has steadfastly kept the flag flying on the National and several Branch websites. Ron will be staying on as Chairman but has recently handed over the reins of the website to a new contractor. Thank you Ron for the tremendous contribution. There are always openings and opportunities for new faces on the branch and national committees so why not take the plunge and get involved. It's a challenging and rewarding commitment.

#### **National Finance Director's Report**

#### ANSA - AUSTRALIAN NATIONAL SPORTFISHING ASSOCIATION LTD ACN 063 293 514

FINANCE DIRECTOR'S REPORT FOR THE YEAR ENDED 30 JUNE 2013 Financial statements for the financial year end 30 June 2013 together with comparative results for the preceding year are appended. The following points are highlighted:

- a) The Association traded at a surplus of \$15305 for the 2012/13 year. This is substantially down on the previous year's surplus of \$30519 but substantially better than the forecast deficit of \$1000. The major factor behind this substantial variation was the receipt of a further \$24420 in FRDC grant money for the Angel Ring National roll out project against which expenditure of \$9132 only was incurred over the 2012/13 financial year. All told \$46420 has been received via the FRDC grant and a further \$44000 remains to be handed over. Expenditure of the grant money has been delayed due to approval impediments most of which have now been resolved. Full drawdown of the remaining \$44000 grant (and expenditure \$80000) have been factored into the 2013/14 budget but actual expenditure may extend beyond the 2013/14 financial year. Notional exclusion of the grant funding and expenditure from the 2012/13 results would have seen the association generate a break even surplus of \$18.
- b) Income over the 2012/13 year of \$50157 was greater than the previous year's level of \$47842 and close to the budget forecast of \$52800. Other than for the timing and amount of the FRDC grant money, the main variance was due to a decreased level of membership fees \$20051 (\$22458 11/12) but the previous year was inflated as a result of the late payment of fees due from the 2010/11 year. ANSA Ware sales were up to \$2120 (\$586 11/12) due to a restocking of ANSA brag mats. Interest earned on term deposits etc of \$2833 (\$2458 11/12) was \$333 more than budget. A claim for underpaid interest over previous years by the ANZ was also successful with an amount of \$733 received in settlement making interest for the year \$3566.
- c) Expenditure over the 2012/13 year was \$34851 as compared to \$17323 for the previous year and substantially below budget forecast of \$54800. Other than for the impact of the FRDC grant moneys, the main variance to budget was expenditure \$2224 on promotional brochures and \$1745 on ANSA banners these were budgeted at \$3000 and \$1000 respectively. Unbudgeted membership fees of \$500 were paid to ARFF but this was offset by non payment of \$250 in membership fees to AFTA. Audit fees of \$550 were paid as opposed to budget \$1200 as we are still awaiting a fee invoice for the audit of the 2011/12 accounts. Phone and Internet expenses were \$1606 and Post & Stationary \$2512 as opposed to budgets of \$900 and \$2000 respectively. Unbudgeted expenditure of \$834 was incurred attending the 2012 Recfishing National Conference.

d) The Association at year end 30 June 2013 possessed total assets of \$124440 (\$109135 @ 2012) consisting primarily of cash at bank \$52284, term deposit \$65213, ANSA Ware stock on hand \$6386 and accrued but unpaid interest \$557, The association has no external liabilities. Overall the Association had a net equity of \$124440 at 30 June 2013 but this includes \$37288 of unexpended FRDC grant moneys.

e) A financial budget forecast for the 2013/14 is attached. For the coming year the company is forecasting a deficit of \$32800. This deficit is predicated on income for the coming year of \$67800 which includes the \$44000 balance of the FRDC grant. Other than for affiliation fees which have been budgeted at \$19000 (to reflect the reduction of some fee categories) all other sources of income are generally in line with actual receipts for 2012/13.

Expenditure of \$100600 is forecast for 2013/14 which includes \$80000 for the Angel Ring project (this may extend into the following year). Audit fees of \$1200 have been budgeted for which includes an expected \$600 for the 2011/12 audit and a like amount for the 2012/13 audit. A provisional budget allowance of \$2000 has been made for possible subsidy of an ANSA delegate attending the World recreational fishing conference in 2014 – this expenditure has not yet been approved by the ANSA Board.

Notional exclusion of the FRDC grant funding and related expenditure should see the association generate a traditional surplus of \$3200 over 2013/14.

#### National Research/Development Director's Report

#### ANSA RESEARCH REPORT 2012/13

Tagging within ANSA continues with Suntag leading the way in Queensland. Westag in Western Australia and Saftag in South Australia continue to function at low levels.

A full report on Suntag and Westag activities is contained in the Infofish Citizen Science and Suntag Report 2012/13 which is available from the Suntag website www.info-fish.net/suntag.

This year the Suntag database passed it's most significant milestone in its 27 years with over 1,000,000 fish and crab records in the database. It is one of the largest volunteer tagged fish databases in the world, probably the largest. Making up that total are 692,000 tagged fish and crabs, 280,500 other fish from catch records and 54,700 recaptures with over 25,000 fishers contributing information to make up that total. Special recognition needs to go to the 100 Frequent Taggers that have tagged over 267,000 fish or almost 40% of the total number tagged.




The support of the Queensland Department of Agriculture, Fisheries and Forestry and all those that have contributed to the program over the past 27 years has allowed the continued growth and development of Suntag to where it is today.

Some of the features of Suntag and the database that make it world class:

- + Built using industrial strength database software and tools
- → Online access through Suntag Online from anywhere in the world with data contributors (taggers/researchers) able to securely access their own data online (read only)
- → Uses data standards where available (eg standard fish names)
- **→** Tagging Manual to Quality Assurance documentation standards
- → Most tagging data in Queensland is in a single database making access and analysis much easier and cheaper
- → Database linked to Google Earth to allow easy and real time visualisation of data
- Photographs and video can be stored along with text data
- ★ Recaptures can be lodged online through the Suntag website with instant feedback on the fish direct from the database

- ★ Recapture certificates sent electronically or by mail to the person that recaptured the fish and the tagger with customised certificates available for some projects
- → Tagging and other data can be lodged online or via email with 98% of data now lodged electronically
- → Tagging awards have been upgraded to improve recognition of contribution of taggers

Having a world-class data collection and storage system ensures that quality data are available however that data needs to be available in a variety of formats to the fishing industry and government to assist in dealing with real world issues that affect the industry and our fisheries. #### National Promotions Director's / Webmasters Report



It must be remembered some hits are from search engines checking on the total world wide web and ensuring all sites are available for searches.

One item of interest is the stats for Mozilla Firefox browser, almost half of the hits were from Firefox. Also Apple mac systems have crept up to 20% of computers used by interested anglers.

Linux would account for most search engines doing a scan. I always find the stats interesting and find changes in the way people look for sites. Google is of course the top search engine used by most people around the world.

#### **National Safety Officer's Report**

The ANSA National project is progressing as outlined, albeit stuck in first gear in the application process and obtaining the approvals needed for installation in most states. At this point in time applications have been submitted and as part of this process an updated Review of Environmental Factors or REF was needed to assist state based land managers to deal with the issue of rubbish and bait discards. Essentially this was not part of the project brief but ANSA felt it was in the interests of maintaining good working relationships with land managers around the country and is working on this request. Also a request from NSW is being completed that required an updated risk assessment and a request from WA to assist them in a rockfishing policy. All these will lay the foundations for the other states and form part of the next phase of the project.

We are still in the approvals phase of the Project and as noted in the application this was going to be the biggest threat to the Projects timely delivery. Currently we have approval for the far north coast of NSW in hand and applications under assessment in WA for 9 new rings, and approvals are being sought for 10 new rings in QLD. We are currently looking at 9 locations in VIC and are just about to start working on the approvals there.

We are on track and slowly getting there.


#### **National Masters Keeper Report**

#### **ANSA New South Wales Report**

The ANSA National Report is a fitting platform to take the opportunity to thank all those who put their hands up to keep the ANSA clubs going around Australia and lets me thank those who put their hands up to take the fight up in NSW and keep the fires going.

It a huge testament to the fact that the ANSA brand is recognisable in NSW through our advocacy, leadership, projects such as Angel Rings and Fishing 4 Therapy and ANSA NSW is constantly seeking and giving advice to the Government of the day, mindful of the fact that sometimes the sneaky buggers do what they want but that's does not stop us or force us to put up the white flag. Rather we keep fighting the good fight as custodians and good stewards of our marine environment in NSW.

Once again it is the hard work at the State Level that needs to be recognised with all the committee members chipping in to help. Some jobs require more recognition and the work Joe Garufi puts in as Secretary is monumental, equal to the work Shane Jasprizza does as our Recorder, Mike Spitzer as Membership Officer and let's not forget Tony Steiner who graduated from Special Project Officer to our new Treasurer. Along with more new faces, Tony was joined by Craig Wilson as our Environmental guru. Rob Sinclair who is bright eyed and bushy tailed, and then the old buggers like John "JB" Burgess, Yanko Serifi and I to take up the slack. It has been an enlightening and successful year for us and the fact we are all still great mates says it all. We enjoy the work we do even though it can get overwhelming and sometimes we all sit back and say "we are only volunteers" and then get straight back into it!

Following are some of the issues outlined in the most recent ANSA NSW Annual Report and discussed with the NSW Delegates;

**Cronulla Fisheries.** Despite a strong campaign to stop the closure of Cronulla Fisheries, including ANSA NSW appearing before an Upper House inquiry, the closure went ahead with a resultant loss of over 100 staff that were not prepared to relocate to regional offices. The loss of so many key research and management staff has had an obvious impact on Fisheries. Those that have stayed on are doing a great job under difficult circumstances. Thankfully the department is now in the process of recruiting new staff and time will hopefully see Fisheries back on top of its brief.

NSW Marine Parks. ANSA NSW did participate in the independent audit of marine parks and we have had preliminary meetings with the members of the newly formed NSW Marine Estate Management Authority and the Marine Expert Knowledge panel which have been set up to replace the NSW Marine Parks Authority and to manage the entire NSW marine estate which includes all coastal waters, estuaries and beaches. One of the immediate benefits to come from all of these activities was an amnesty to allow recreational line fishing from ocean beaches and headlands in most marine park sanctuary zones. An assessment of the impacts of this amnesty is currently in process. ANSA NSW has high hopes that these new bodies will engage with recreational fishers and that the outcome will be a better coordinated management of our marine estate with proper regard to recreational fishing as an important socio economic activity.

**Grey Nurse Sharks**. ANSA NSW has had a long and active role in the management of GNS and we did participate in the NSW review of GNS Critical Habitat Zones and the type of fishing activity and tackle allowed in some of these zones. Outcomes of these reviews saw the revocation of GNS critical habitat at Bass Point and modification of the shape of the habitat zone at magic Point (Maroubra) and Green Island (South West Rocks). Land based line fishing with bait is now allowed adjacent to these modified zones.

**Botany Bay.** ANSA NSW has been represented on a number of committees associated with the expansion of Port Botany. We have been fortunate to stop a number of proposals to restrict fishing access on waters adjacent to the Port. The issue of compensation for loss of much of the bay (which is a recreational fishing haven) as part of the port reclamation has been a sore point for ANSA for many years. We have unsuccessfully pushed the compensation issue with a variety of responsible Ministers over the past decade. Now that the port has been privatised the NSW government has undertaken it will provide funding for the installation of 2 offshore artificial reefs south of Botany Bay as part of a compensation package. A similar off

shore artificial reef compensation package has been negotiated for the south coast following privatisation of Port Kembla.

Caltex Dredging. ANSA NSW has formally asked the Federal Environment Minister to intervene in the proposal by Caltex to dredge and expand its berthing facilities at Kurnell and to dispose of some 153000 cubic metres of TBT contaminated sediment by dumping the bulk of it at sea 10km south east of Sydney Heads - TBT is a very toxic substance historically associated with anti-fouling. NSW authorities have given a conditional green light to the dredging proposal but the dumping at sea requires Commonwealth approval. ANSA's NSW preference is that the contaminated spoil be treated and disposed off at an appropriate land fill site. Compensatory offsets for loss of recreational fishing access will be sought from Caltex regardless of the outcome.

Review of NSW saltwater/ Freshwater Fishing Rules ANSA NSW has participated in the review process and have questioned the lack of science and purpose behind the proposed bag and size limit reviews which essentially involve a halving of bag limits for most bread and butter species. None of these species is under threat from recreational fishing or is overfished. There has been no evaluation of the conservation effectiveness of the rule changes introduced in 2007 or any assessment of the impact the reduced bag limit changes will have on recreational take if adopted and made law. Hopefully good common sense will prevail and any changes, if implemented, will have minimal impact on recreational fishers and will not infringe upon the capacity of recreational fishers to exercise value decisions on how many fish to take and keep. It's a matter of fact that 90% of all finfish captures come from landing of fewer than 20 fish per angler per day and that only 1% of fishers rarely catch their bag limits. This is a standing testimony to recreational fisher conservation ethos which will persist regardless of bag limits. It is also naive to believe that these proposed regulations will reduce the incidence of illegal fishing and sale. These shamateurs have no regard for the law and will continue to act illicitly regardless of whatever bag and size limits are in place. Stronger compliance is what's needed to address this problem.

Boat Trailer Parking. Most owners of boats over 6m in length would probably be unaware that it is illegal to park a vehicle (including a trailer over 7.5m including whatever is loaded on the trailer) on a public road in a built up area for more than one hour. A number of Sydney coastal and harbour side councils have been pushing for some time have the National Road Rules amended so that they have very broad delegated powers to issue infringement notices and impose penalties for parking of boat trailers of any size on public roads. To date councils have not been given these powers but a Boat Trailer Working group was established by the NSW government last year to consider all options. A report and recommendations have been completed and these have yet to be decided upon by the NSW government. Regrettably though Councils do have the power under section 200 of the Road Rules to impose fines on parked trailers over 7.5m in length. Historically few councils have opted to exercise this delegated power until now. One eastern suburbs council has issued warning notices to all boat/trailer rig owners over 7.5 m to move their boats off the road or face heavy fines. None of these trailers were parked unsafely and all were registered and in regular use. The concern now is that this precedent may spread to other councils. ANSA NSW has taken this issue up with the NSW Minister for Roads and Ports and has requested ACORF to write to the NSW Fisheries Minister seeking her intercession. Rule 200 has application not just in NSW but across all states and territories. Hopefully we can get this sorted out before the cancer spreads.

**Peak Body Representation.** ANSA NSW has maintained its presence on the NSW ACORF and Licence Trust Expenditure Committees albeit that the future structure and composition of both these bodies is likely to change in the near future. ANSA NSW is a driving force behind the RFA (NSW Recreational Fishing Alliance).

Taggers, ANSA members and interested fisherpeople, it is my pleasure to present the Annual report for 2013.


2013 is another milestone year for SAFTAG as we placed our 5000th tag this year.


At the time of writing we also have 3 new clubs coming on-board which should help grow SAFTAG's tagging database over the years to come. A hearty welcome to members of

2013 has also taken SAFTAG into the digital age. Our recapture certificates are now sent out by email so both taggers and recapturers are able to view their certs and optionally print them out.

From 1<sup>st</sup> July this year we will be introducing 3 new tagging achievement awards.

EPIC TAGGER	for tagging	100 fish of any one species
LEGENDARY TAGGER	for tagging	250 fish of any one species
ULTIMATE TAGGER	for tagging	1000 fish of any one species

Only fish of legal size will qualify. We wish to reward fish that were released by choice rather than by legality. SAFTAG also discourages intentional targetting of undersized fish but we do encourage tagging of all fish, on the approved species list, that are captured incidentally, IF they're big enough to be unhindered by a tag.

Epic and Legendary awards will count only fish tagged after 1<sup>st</sup> July 2013 but the Ultimate award will also count fish tagged in prior years. Keen taggers should qualify for Epic or Legendary after a year or three. The Ultimate award is expected to take a lifetime for most anglers.

The current approved species are:-
